** Proof of \$200,000 of gross archery sales excluding internet sales must be verified prior to eligibility for membership.

If my business is accepted into the NABA, I agree to keep my accounts with all manufacturers and/or vendors current and agree to accept a probationary status (COD with all vendors) if my business is reported to have 6 months of delinquent accounts.

I understand there will be annual dues of \$300.00 per year payable upon notification of acceptance. Membership Dues are to be collected by July 1st of each calendar year. All new members are required to attend the National Archery Buyers Association (NABA) Trade Show held in Reno, NV during your first year of membership. Owner(s) or employee with purchasing/ordering authority are required to attend the NABA Show the first year of membership.

If these facts are not true as stated and/or there is a violation of membership requirements as stated above may result in termination membership.

A new retailer member must have been in the retail archery business, with a storefront, for a minimum of two (2) years.

A new retailer member must provide proof of income (i.e. Tax return, financial statement, POP year end) and have generated \$200,000 in retail archery sales over the past 12 months (excluding internet sales.)

A new retailer is required to maintain a physical store location with established business hours and open to the public a minimum of 5 days per week.

A new retailer must have a clear credit history for the past 5 years. NABA does a simple third-party credit check and requires a minimum of 5 credit references on the application form.

Owner(s) or employee with purchasing/ordering authority is required to attend the NABA Reno Show for the first year of membership.

Only owner(s) or employee with purchasing/ordering authority are allowed to place orders and represent the company at Trade Shows.

A new retailer should make full effort to visit all participating booths at the ATA and NABA Reno Trade Show to view and discuss new and current products as well as show specials.

All Retailer members are solely responsible to abide by the payment terms and condition specified by the vendors. Members who fall delinquent with their accounts agree to accept a probationary status (COD) with all NABA Vendors until their accounts are made current. Members agree that should they be able to correct the probationary status their membership will be terminated with NABA.

A new retailer must submit two pictures of their retail business. One of the exterior store front and one of the retail space to be forwarded with this application.

If these facts are not true as stated and/or there is a violation of membership requirements as stated above may result in termination of membership.
